| | I attest that I am not obtaining this animal for use in any kind of experimentation, or for the sale to any agency that experiment on animals. |
| | Lucky Paws Rescue does not necessarily know the nature of the animal, or its characteristics, and gives no warranties, expressed and/or implied, of temperament or fitness. I confirm that I have been provided information on the pet's current health status, noting any known pre-existing conditions. I understand that the pet is delivered "as is." I understand that the pet should be isolated for a period of time from my own pets, to the extent possible, in the event that it has been exposed to any type of illness. |

The cat is not to be given, or sold, to another individual, institution, or organization, without the express written permission of Lucky Paws Rescue.
